This privacy policy applies to our use of any, and all, Data collected by us or provided by you in relation to your use of the Website.

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Sage Proofreading and Copyediting Services and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Sage Proofreading and Copyediting Services is the "data controller". This means that Sage Proofreading and Copyediting Services determines the purposes for which, and the manner in which, your Data is processed.

### **Data collected**

- 5. We may collect the following Data, which includes personal Data, from you:

### Data that is given to us by you

- 7. Sage Proofreading and Copyediting Services will collect your Data in a number of ways, for example:

  - c. when you elect to receive marketing communications from us;

### Data that is collected automatically

#### Who we share Data with

## **Keeping Data secure**

- 14. We will use technical and organisational measures to safeguard your Data, for example:

  - b. we store your Data on secure servers.
  - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

#### **Data retention**

- 18. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

### Your rights

- 19. You have the following rights in relation to your Data:
  - a. Right to access the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
